Whereas, the extension would be to Town Water District #2 in the Town of Glenville along Sacandaga Road and includes the parcels identified on the Town of Glenville Tax Map as SBL 29.15-4-1, 29.15-4-2.11 and 29.15-4-3, a Planned Unit Development to include nine (9) 8 unit apartment buildings and a 4,800 SF retail building with four (4) apartments above, and Whereas, the Village currently provides water to Town Water District #2 and the Village Superintendent of Public Works, Andrew Kohout has reviewed the proposed water service extension and finds that the Village of Scotia water pumping station and distribution system has sufficient capacity for the proposed service extension, now therefore,
