Washington Avenue (Iroquois Street) – Active Solar Development and Raymond Piotrowski

Representatives Ryan Farnum of Creighton Manning and Frank McCleneghen of Active Solar were in attendance to present the application to install a Community Solar Array at the parcel ID 39.39-1-1. The parcel is zoned as Industrial and therefore would not require a zoning variance. The proposal includes 6-foot chain link fence surround. The Planning Board, as well as Schenectady County suggest a 7-foot fence without barbed wire. The applicant agrees and prefers this alteration. There will be an access gate with a knock box for emergency access. The service road will be gravel and not paved. Residents in attendance voiced concerns about increasing the flood risk. The proposal shall not affect the level of flooding. Panels are also water/weather resistant and if damaged, would be replaced at the owners' expense. There shall be no change to drainage pattern. Applicant has followed DEC guidelines for stormwater management. No lighting is proposed. Panels are positioned at a South facing angle and are anti-glare. The applicant shall provide a decommissioning plan with letter of credit as well as a Full Environmental SEQRA. Residents have also requested a vegetative screening on the North side of the fence. The applicant shall install vegetation that is appropriate for the soil and shall be maintained. The applicant will be seeking a PILOT agreement with the Village Board of Trustees. Attorney Lydia Marola stated that there is an easement on the property and this should be identified in the site plan. In the event that there is damage to the Village roadways during construction, the applicant may also be responsible for correcting. A Public Hearing shall be held during the next regularly scheduled Planning Board meeting prior to any further approval.
