DAIRY CIRCUS LOAN

Whereas, the Village received a FY 2000 New York State Small Cities Community Development Block Grant (CDBG) award under the New York State administered Community Development Block Grant Program and the loan repayments derived from the prior grant award has capitalized the Village’s Economic Development Revolving Loan Fund, and
Whereas, the Village and Robb L. Clemons d/b/a Dairy Circus entered into a loan agreement dated September 21, 2017 under the Village’s Economic Development Revolving Loan Program; and
Whereas, the Village and the Borrower are desirous of amending the terms of the loan, now therefore
Be it Resolved, that the Board of Trustees authorizes the Mayor to sign an amended Loan Agreement and Note in a form acceptable to the Village Attorney, with Robb L. Clemons d/b/a Dairy Circus extending the term 3 years commencing December 1, 2022 at the same interest rate and with the current balance amortized over three years.
