### **RELOCATION OF VILLAGE STAFF AND PUBLIC SPACE**

Whereas, the roof of Village Hall has been compromised and the ceiling has partially fallen rendering the second flooring unusable, and

Whereas, staff, equipment, meetings and court will have to be relocated from the second floor, and

Whereas, there will be expense to moving computer and other equipment, relocating staff, and for providing new space for meetings and court, and

Whereas, the Village Economic Development Fund monies are not required by law or otherwise to be used for Economic Development and may be used for any Village purpose, now therefore Be it Resolved, that the Board of Trustees authorizes up to \$36,000 of Economic Development funds to be used for the moving and reinstallation of computer and other equipment, moving and obtaining space for displaced staff, village meetings and court along with any other expense associated with vacating operations from the second floor of Village Hall.
