CONTRACT FOR ALERTING SYSTEM

Whereas, the Fire House is in need of an expanded alerting system, now therefore

Be it Resolved, that the Board of Trustees authorizes the Mayor to sign an agreement with Bryx Inc. for an Alerting System in an amount not to exceed \$27,000.00, with funded as follows:

- \$10,360 from remaining Grant Funds
- \$16,640 from Municipal Facilities Project Phase 2-FFE Budget

SALE OF WATER METERS TO THE TOWN OF GLENVILLE

Whereas, the water meters installed in the properties are owned by the Village of Scotia, and

Whereas, the Village will no longer have need of the meters currently installed in Town Water District #11 since it will no longer be providing water to the district, now therefore

Be it Resolved, that the Board of Trustees finds (37) Various size used water meters as listed in a memo from the Superintendent of Public Works dated March 14, 2025 as surplus, and

Be it Further Resolved, that the Board of Trustees authorizes the Mayor to sign an agreement with the Town of Glenville for the sale of said water meters to the Town for \$7,500.00.
