PRIVILEGE OF THE FLOOR

Mayor Bucciferro opened the privilege of the floor at 6:35p.m.

Keith Phillips, 17 Liberty Drive, Ballston Spa; Captain of Scotia Fire Department read the following:

I'm here to speak on the alerting system, comments from last week's work session and the related Daily Gazette article from Monday. There are several points that have to be addressed.

For the record, we have been delayed on several calls since moving into the new station because our pagers did not go off. A delay in this business could mean the difference between life and death. Fires jump in size every 30 seconds. With the plastics in building construction, furniture manufacturing and everyday household products - they burn faster and hotter than ever before. Additionally, from the EMS side, every minute that we delay in treating a patient could mean tissue death - brain tissue, heart tissue, wherever the oxygen is cut off. And this is only the tip of the iceberg when it comes to why response times matter.

I was recently working when our pagers didn't go off for a call at midnight. I just happened to be still working and saw the call come across my phone. By the time I alerted my shift, left the station and arrived - over 8 minutes had passed. That's almost double our normal response time - significant delay. I was worried it would happen again, so I spent the rest of the night staring at the computer screen and my phone so we wouldn't miss anything. Another call went out at 3:05 in the morning and the pagers didn't go off. This call was right behind the firehouse and took us over 5 minutes to respond because of the delay. Our pagers were on with the volume turned up. Similar instances have happened several times since we moved in.

In the article, the mayor is quoted as saying he suspects the pager issue is a "volume issue". This is 100% false. While I know this can't be a back and forth - I would question where are the facts behind this statement? You instantly and baselessly called the firefighters incompetent in a front page news article. You lowered the reputation of the firefighters with zero proof to back up this false statement. Case in point, while on an emergency call yesterday, a resident said to the shift, "Looks like you guys have to turn your pagers up." This is totally unacceptable. The building committee makes a monumental mistake by not installing the most essential piece of equipment

for a fire station and somehow the Mayor blames the firefighters for delays in calls. While a retraction and public apology is warranted, the damage has been done. It's another one of those genies you can't put back in the bottle. You can imagine the reaction of employees when your boss calls you incompetent in the newspaper.

On 6/12/24, prior to moving in, I wrote you all an email warning of the consequences of not having an alerting system. I said, response times would increase. You built a bigger building, put us further away from the apparatus and didn't give us an alerting system. It seemed like a straightforward and obvious problem, but it was said in a building committee meeting that I was wrong and didn't know what I was talking about. Well here we are - over 7 months post move - and we now have the facts.

From July 2016 to July 2024 our average response time was 3 minutes and 50 seconds. Since we moved in July 2024, our response time has increased to 4 minutes and 38 seconds. This is a 48 second increase. Should be an unacceptable number. You made response times worse by building the firehouse in its current state. This should be like an Olympic sprint where we are trying to shave seconds off, not adding almost a minute.

But it gets worse. Prior to 2016, we had a partial alerting system that went off for fire alarms in approx. 10-12 buildings within our districts. It would ring prior to dispatch toning us out for the schools, Holyrood, and some buildings in the Industrial Park. The technology became antiquated and the Village did not want to pay to replace it. Average response times during this time, from when we started digital reporting in 2013 to July 2016 were 2 minutes and 58 seconds.

2 minutes and 58 seconds in 2016 to 4 minutes and 38 seconds today. A 1 minute and 40 second difference. So going from a smaller building with a partial alerting system to a larger building with no alerting system is an increase of 1 minute and 40 seconds in average response times. This should speak volumes. The village government is making choices that are hampering the safety and wellbeing of its residents and their property and in turn making it more dangerous for its firefighters. That is not debatable - that is a fact.

It was stated at last week's work session that some stations, including those with career members, do not have alerting systems. Our state union is split into seven districts with our district having 18 municipal fire departments. All of them have alerting systems - except us. That's Schenectady, Troy, Saratoga, Kingston, Watervliet, Gloversville, Johnstown, Albany, Glens Falls, Plattsburgh, Cohoes, Rensselaer, Amsterdam, Green Island, Niskayuna, Lake Placid and Colonie. All of them, but us. So again it begs the question - where are you getting your information?

As far as the funding goes - that's up to you to decide. But I will tell you that starting on meeting one on 6/20/22 - an alerting system or overhead paging system was talked about as part of the project. I have the meeting minutes here, since I was at the meeting, where it was clearly talked about as part of the FF&E budget. Those talks continued and progressed until the moment the firefighters were removed from the building committee in January of 2023. Someone after that point made a conscious decision to remove it from the project. In addition, there are 4 speakers sitting on the mezzanine that were purchased at the direction of the construction manager as part of this project for an alerting system. Why would they be purchased if a system was never part of the project? Why would this board approve the purchase of those speakers, if this system wasn't part of the project?

A comment in the article stated that some trustees “emphasized that there’s no changing the past and that the focus should be on public safety.” This is an interesting sentence. While we can’t change the past, we should find out how this issue came to be. This a huge mistake and oversight by the building committee. Someone should be held responsible. Go ask a resident that you built a new firehouse with \$8M of their money and there is no bell that goes off for when we get a call. See their reaction. In the article, Trustee Gray states that the point of the firehouse was firefighter safety and the ability to provide effective service to the community. A slower service is ineffective. You have failed in your goals of the project. If your focus was really on public safety, then you would have been cognizant of finding ways to increase speed, efficiency and effectiveness to better serve the community. As it stands right now, you didn’t. We are over 7 months in from the move, and I can tell you as a senior member of this department, a Captain in this fire department and someone who took an oath to protect and help this community you have failed the goals of this project and hurt public safety. The technology exists to fix all of this - you just have to bring it up for a vote and vote to actually focus on public safety

SCHENECTADY COUNTY FOOD COUNCIL'S ADVOCACY AND EMPOWERMENT WORKING GROUP

Whereas, the 2021 Schenectady County Community Needs Assessment found children under the age of five living in poverty increased to 34% in the Scotia-Glenville School District. The Village of Scotia had the second-highest percentage of households in the County earning less than \$25,000 per year, resulting in an increased need for food support programs, and

Whereas, it is the vision of the Schenectady County Food Council that all residents of Schenectady County, including residents of the Village of Scotia will have consistent, reliable, and equitable access to a sufficient amount of healthy food for themselves and their families, and

Whereas, as part of achieving that vision, the Council's Advocacy and Empowerment Working Group empowers all stakeholders in our local food system to advocate for changes at all levels of government, and

Whereas, over the past three months, the Schenectady County Food Council has engaged with a wide variety of stakeholders from across our food system to develop the following priorities for the NYS FY 2026 Budget:

- Supporting legislation A.1318 and S.665 introduced by Assemblymember Gonzalez-Rojas and Senator May which would guarantee a minimum Supplemental Nutrition Assistance Program (SNAP) minimum monthly benefit of \$100;
- Fully funding the Hunger Prevention and Nutrition Assistance Program (HPNAP) and Nourish NY program at \$75 Million Each;

Whereas, the Schenectady County Food Council's Advocacy and Empowerment Working Group sent a letter requesting support of these priorities in the NYS FY 2026 to Governor Kathy Hochul; State Senator James Tedisco (NY-44); State Senator Patricia Fahy (NY-46); State Assemblymember Phil Steck (NY-110); State Assemblymember Angelo Santabarbara (NY-111); State Assemblymember Mary Beth Walsh (NY-112) now therefore,
