

Mayor Bucciferro called the meeting to order at 7:00p.m.

PRESENT: Trustee Brown, Cook, Gray, Solotruck & Mayor Bucciferro

Mayor Bucciferro stated that after review of the Tentative Budget he would like to discuss the following amendments:

- Full-Time Building Inspector position reduced to Part-Time
- Elimination of two summer employers; one DPW, one Park
- Increase amount of Fund Balance; offset by parking fees at Collins Park for non-residents, implementation of new parking system, implementation of commercial fire inspections.

Trustee Cook recommended moving garbage from a tax base system to a fee base system outside of the budget; waste collection fees would equalize the costs evenly over all parcels.

FIRE DEPARTMENT MUTUAL AID SERVICES

Trustee Brown asked for an analysis of mutual aid support provided by the Fire Department for ALS support; not fire support, and the impact of that mutual aid on the budget. Neighboring departments are not able to provide support to the Village since they do not provide the same level of training.

FIRE DEPARTMENT VOLUNTEERS

Trustee Cook asked that the Chief have a plan put into place for recruitment and retention of volunteers; to create our own volunteer base or partner with other volunteer departments. Trustee Cook asked for the Chief to be directed to hold three annual volunteer drives per year. Cook asked for a training report related to the current volunteers; Mayor will ask Chief to provide report.

RESIDENTIAL SIDEWALK PROGRAM

MOVED by Trustee Brown, seconded by Trustee Cook to eliminate the sidewalk program.

HIRING FREEZE
